HISTORY: This publication is full revision with major changes to reflect the transfer of the Hunting and Fishing Program Administration from Morale, Welfare, and Recreation (MWR) to Natural Resources in the Environmental Management Division (EMD). Also, this document is updated to reflect appropriate annual revisions to Hunting, Fishing, and Trapping on Redstone Arsenal (RSA).

SUMMARY: This policy sets forth the rules and guidelines for Hunting, Fishing, and Trapping within the boundaries of RSA, henceforth referred to as RSA.

APPLICABILITY: This policy applies to all persons entering or residing on RSA.

PROPONENT AGENCY: USAG-Redstone, Directorate of Public Works (DPW), EMD, Cultural and Natural Resources (CNR) Branch.

SUPPLEMENTATION: Supplementation of this regulation by subordinate commanders is strictly prohibited.

SUGGESTED IMPROVEMENTS: Users can send comments and suggested improvements through a Department of the Army (DA) Form 2028 (Recommended Changes to Publications and Blank Forms) to the Director of the EMD, CNR, RSA, AL 35898-5000.

1. PURPOSE

- a. This document establishes policy, assigns responsibilities, and prescribes Hunting, Fishing, and Trapping procedures on RSA.
- b. Seasons, hours, legal game, violations and penalties, daily bag limits, hunting ages, and possession limits for all game and fish are set by Federal and State Laws and Regulations.
- c. All Federal and State Laws on Hunting, Fishing, and Trapping apply to persons conducting these activities on RSA. This policy, as well as special notices, rules, and procedures, are posted at Building 5138 Environmental Management Conservation Annex, and on the Redstone I-Sportsman website.
- d. Installation Hunting, Fishing, and Trapping activities may be closed, as necessary, in support of installation activities, training, or security requirements.

2. STATE AND FEDERAL LAWS

- a. All persons participating in hunting and fishing activities on RSA, will comply with State and Federal fish, game, and Natural Resources laws as well as all Army and RSA regulations and will cooperate fully with representatives of law enforcement agencies.
- b. In addition to appropriate permits issued through the DPW Hunting and Fishing Program on RSA, individuals must possess valid licenses issued by State of Alabama for each game species pursued.
- c. All firearms brought onto the installation will be registered with Directorate of Emergency Services (DES) Building 3623 in accordance with Army Regulation (AR) 190-11 and RSA 190-44. Civilians must print and bring the applications form, (FC Form 2635) obtained through the I-Sportsman web portal https://redstone.isportsman.net/ to RSA Police Headquarters, Building 3623. Firearms will not be transported inside the building. In accordance with AR 190-11, Chapter 4-5 and AR 190-13, Chapter 8, non-Department of Defense ID cardholders will be required to obtain a one-day pass for a hunting permit and favorably pass a criminal background check annually. A visitor pass and weapons permit will be required to obtain a hunter's permit.
- d. A Migratory Bird Permit and Federal Duck Stamp are both required, in addition to appropriate permits sold by the DPW Fish and Wildlife Program, to hunt waterfowl on RSA.

3. RESPONSIBILITIES

- a. The Garrison Commander (GC) has delegated authority to plan, coordinate, and implement fish and wildlife management in accordance with (IAW) AR 200-1 and the Integrated Natural Resources Management Plan (INRMP) to the Director of DPW. The Director of DPW has further delegated responsibility for fish and wildlife management to the Conservation Branch, Fish and Wildlife Program Manager. The GC maintains the approval authority for all exceptions to policy.
- b. The hunting and fishing program is administered through the RSA DPW EMD. The CNR will perform the administrative functions necessary to assign hunters and fishermen to available areas on RSA via the I-Sportsman online application. The EMD-CNR will do the following:
- 1. Administer, manage, and promote the Hunting, Fishing, Trapping, and mountain biking program activities on RSA. Coordinate with Federal and State officials to ensure program regulations compliance.
- 2. Maintain the I-Sportsman recreational access system for administration, logistics, and access management of customers into authorized activity test range

areas. Available activity areas will be posted on the Redstone I-Sportsman website.

- 3. Maintain the I-Sportsman online application and fee payment system for reimbursement into Natural Resources 21X funding accounts. Natural Resources will manage revenues and expenses of the recreational programs to ensure economic viability and long-term sustainment.
- 4. Review and update the Hunting and Fishing Policy annually, staff the policy for legal review and GC signature, and provide the policy to patrons upon request.
- 5. Conduct annual hunter safety orientations for all RSA hunters before the beginning of each annual hunting season. Orientations and safety briefings will be available on the I-Sportsman website for new hunters unable to attend pre-season orientations. Natural Resources staff may be available to provide in-person guidance.
- 6. Coordinate with the DES; Directorate of Plans, Training, Mobilizations, and Security (DPTMS); RSA tenant organizations; and approved reporting contractors to collect weekly reports for utilization of restricted areas for hunting, fishing, and mountain biking to be published in the I-Sportsman customer portal.
- 7. Maintain and monitor harvest data, set hunting, creel, trapping limits, and restrictions as necessary for proper management of all species according to accepted wildlife science and ecological principles. Implement changes to limits and restrictions as needed for program sustainment.
- 8. Perform and administer wildlife conservation, ecological management activities, fish and game habitat, and population management to include nuisance and invasive species management, as prescribed in the INRMP. These actions will be exempt from all RSA Hunting, Fishing, and Trapping permit and license requirements.
- 9. Administer access to mixed-use hunting areas for other recreational activities including hiking and mountain biking. Access to these areas shall be granted through the I-Sportsman online portal. These areas include Weeden and Madkin Mountains.
- 10. Provide staffing resources to operate the Recreational Hunting, Fishing, and Trapping service center in Building 5138. The facility will provide scheduled in-person customer support services, administrative assistance, and technical assistance to hunting and fishing patrons.
- c. The DPW/EMD Hunting and Fishing Program Manager is authorized by the GC to suspend and/or revoke hunting and fishing permits for violations of the policies and/or procedures prescribed in this regulation. Installation policy violations and corresponding penalties are specified in Appendix A. Violations of the state laws and associated penalties shall be adjudicated with the Federal Magistrate.

- d. The GC has delegated authority to the Installation Provost Marshal Office (Chief of Police) as the Chief of the Game Wardens for enforcement of hunting and fishing laws and regulations. The DES and its Conservation Law Enforcement Officers (Game Wardens) will do the following:
- 1. Enforce the provisions of this policy and all State and Federal hunting laws and regulations on RSA.
- 2. Log violations into I-Sportsman and maintain records of permit holders cited for Hunting, Fishing, and Trapping violations.
- 3. As authorized by the GC, to suspend and/or revoke hunting and fishing permits for violations of the policies and/or procedures prescribed in this regulation. Installation policy violations and corresponding penalties are specified in Appendix A. Violations of the state laws and associated penalties shall be adjudicated with the Federal Magistrate.
- 4. Assist in the control of nuisance wildlife and in conducting studies related to wildlife and habitat management in conjunction with the USAG-Redstone Wildlife Biologist, with the discretion and approval of the CLEO Supervisor.
- 5. Facilitate the registration of all weapons entering RSA at Building 3623 in accordance with AR 190-11 and RSA Firearms registration policy. The firearms registration form 2313 will be posted on the I-Sportsman online portal http://redstone.isportsman.net and at the Natural Resources Annex, Building 5138.
- 6. Coordinate with range operating tenants and ensure that Range Support in Building 7390 functions as the central organization for collecting and reporting of hunting area availability by means of a weekly standing data call. All RSA organizations identified with missions using hunting areas will provide input identifying areas necessary to close on a day-by-day basis for one week before the report's effective date.
- 7. Disseminates the weekly hunting report to the Safety Office, DPW, DPTMS, and EMD.
- 8. Establish responsible points of contact for reporting hunting areas that need to be closed for mission requirements. This report will meet established hunting requirements. The schedule will be made available to the DPW EMD.
 - e. The DPW will do the following:
- 1. In coordination with Contracting Officer Representatives, establish a process for selected contractors working over the entire installation to be able to report their work requirements in hunting areas directly to the EMD/CNR and CLEO.

- 2. Provide resources to maintain and operate the Natural Resources Annex, building 5138, as a customer service and administrative facility to include utilities, building, grounds maintenance, repair, and Information Technology infrastructure.
- f. All Redstone tenant organizations controlling hunting lands on RSA for mission activities shall:
- 1. Establish a single point of contact responsible for reporting to the USAG-Redstone DPTMS, Range Support, hunting area availability, utilization and meeting established reporting schedules.
- 2. Make available for hunting purposes all hunting areas not directly and immediately required for the mission.
- 3. Report unexpected changes to the availability of hunting areas for recreation to the CLEO/Range Support as soon as a change is identified, to ensure that workers and hunters are safely in and out of the affected areas respectively.
- 4. Always provide access for law enforcement officers and DPW/EMD Natural Resources staff during non-training events and emergencies.

4. ELIGIBILITY

- a. Active duty and retired Servicemembers, their dependents (with ID card), Reserve Component Servicemembers, Gold Star Family Members, Purple Heart recipients, former prisoners of war, and all Veterans with service-connected disabilities may hunt, fish, and trap on RSA. The permit fee for these persons is \$50.00 per year.
- b. Active duty and retired Servicemembers may sponsor up to two guests annually for a consecutive 72- hour period, without obtaining a hunting permit. The sponsored guest must complete the online hunter safety orientation and register in I-Sportsman, \$25.00 fee. Sponsors must register guests with the EMD at the Natural Resources Service Center Building 5138 before hunting.
- c. Guests of active duty and retired Servicemembers desiring to hunt for longer than 72 consecutive hours must obtain an RSA hunting permit and attend orientation. Guests must be sponsored and accompanied no matter the length of stay. Dependents of active duty and retired Servicemembers must be under the age of 23 unless that person is a spouse of the sponsor. The permit fee for these persons is \$75.00 per year.
- d. Current and retired Civilian employees of the United States Government assigned to RSA and their accompanied dependents (under age 23 unless a spouse) may hunt, fish, and trap (no waterfowl hunting). Civilian employees are not authorized to sponsor guests. The permit fee for these persons is \$100.00 per year.
 - e. Full-time RSA contract employees with active 40-hour-per-week contracts with gate

access badges, may hunt (not waterfowl), fish, and trap. These eligible employees may sponsor their dependent family members (under age 23 unless a spouse) to participate in these activities and must always accompany them when dependents are engaged in these recreational activities. Contractor employees may sponsor no more than two dependents. Part-time/on-call contractor employees are not authorized to participate in hunting or trapping activities. It is the contract employees' responsibility to immediately cease all hunting/trapping activity and notify the EMD if the contract, or the contractor's employment under the contract is terminated. Contractor employees are not authorized to sponsor guests. The permit fee for these persons is \$150.00 per year.

- f. Non-shooting, non-fishing guests may accompany registered account holders without creating an I-Sportsman account. Children between the ages of 9-15 may participate in youth hunts. No one under age 9 may handle a weapon.
- g. Persons who have lost their eligibility to hunt, fish, or trap in the state are not allowed to hunt, fish, or trap on RSA. Persons who lose their state eligibility to hunt, fish, or trap after receiving their RSA permit must return their RSA permit to EMD, and cease all hunting, fishing, or trapping on RSA. Permit fees cannot be refunded for persons who have lost their eligibility.
- h. Mountain Biking and Hiking in the mixed areas of Madkin and Weeden Mountains must register in I-Sportsman (\$25.00 registration fee).

5. LICENSES AND PERMITS

- a. An RSA hunting and trapping permit is required for all persons aged 16 and older including guests and family members. Permits are available by fee through the I-Sportsman online portal, https://redstone.isportsman.net. Users must register, create an I-Sportsman account, and provide proof of required State licenses, a hunter education certificate, and RSA firearm(s) permit. By receiving an RSA Hunting, Fishing and Trapping Permit, the receiver agrees to comply with all applicable laws, regulations, and this policy.
- b. The RSA Natural Resources will provide online hunter orientation presentations to discuss the hazards specific to RSA. Verification of completion of the RSA hunter safety briefing is required for all hunters to obtain a hunting permit. RSA Weapons/ Firearms Permit is required if using a shotgun, rifle, muzzleloader, or pellet rifle. A Firearms Permit is not required if using archery.
- c. Children between the ages of 9-15 may participate in youth hunts while accompanied by a registered user.
- d. All activities related to nuisance wildlife control, depredation hunts, or scientific studies are exempt from permit or license requirements and will be managed through the DPW, EMD, and Conservation Law Enforcement.

- e. Permit fees shall be collected by credit card payment within the I-Sportsman online portal. Permit fees shall be assessed as follows:
 - 1. Active duty and retired military: \$50.00 per year.
- 2. Sponsored guest of active duty and retired military (longer than 72 hours access): \$75.00 per year.
 - 3. Department of Army and Department of Defense Civilians: \$100.00 per year.
 - 4. Other persons authorized by a current contract with access to RSA: \$150.00 per year.

6. HUNTING PROCEDURES

- a. Hunting is authorized in designated areas only. Hunting, Fishing, and Trapping are authorized 5 days a week, Thursday through Monday (no hunting Tuesdays and Wednesdays) when applicable seasons and areas are open. There is no hunting on Christmas Day and New Years Day. Hunting will be open until noon on Thanksgiving Day, Christmas Eve, and New Years Eve. Hunting is available on all other Federal Holidays unless the holiday falls on a Tuesday or Wednesday.
- b. Hunters should request a hunting area by logging into the I-Sportsman system to find an available area. Active-duty Service members may reserve an available area between 1600-1800 hours for the next day's hunt. Active Duty Retired may reserve an area 1800-1900 hours. All others may reserve an available area after 1900 hours. Hunters are prohibited from signing into an area with the intent to not hunt with intent to block other hunters from hunting that area. Hunters who are signed into an area must clear the area before leaving the Installation. Hunters who are signed into areas are expected to hunt the area. If they are not able to hunt, they must clear I-Sportsman immediately.
- c. Dash placards will be correctly and legibly filled out and displayed on the vehicle dash. Hunters must clear hunting areas within the prescribed time limits.
- d. Hunters hunting within Wheeler National Wildlife Refuge (WNWR) will hunt only in the portion identified on the map with corresponding area numbers, e.g. hunters in Area 55 may also hunt in Area 55R. Only deer and raccoons (non-toxic shot #6 or smaller for raccoons) may be hunted on WNWR lands.
- e. Hunters may, after receiving approval from a Conservation Law Enforcement Officer (CLEO) and EMD staff member, look for wounded game in another open hunting area.
- f. Hunters must report all wildlife taken at the end of each hunting day on the I-Sportsman mobile application. The Redstone CLEO shall acknowledge, or optionally

inspect, all deer and turkey harvested before leaving RSA. Bucks must have at least a 15" outside spread or at least one antler with a 15" main beam length. Doe must have a milk sac intact. The hunter that harvests a deer or turkey must check with the CLEO or Wildlife Biologist before donating a harvest to another person.

- g. The following actions are prohibited. See Appendix A for additional information:
 - 1. Cutting of trees.
 - 2. Use of more than four dogs per group while small game hunting.
 - 3. Driving or participating in deer drives.
 - 4. Construction or use of permanent blinds/tree stands.
 - 5. Leaving hunting equipment in the field overnight.
 - 6. Destruction of evidence of sex of deer or turkey.
 - 7. Discharge of weapon in an unsafe manner.
 - 8. Hunting in an unauthorized area.
 - 9. Tampering with other's personal or government property.
- 10. Loaning or altering any official document pertaining to Hunting, Fishing, or Trapping.
- 11. Use, in possession of, or being under the influence of alcohol, physically and/or mind-altering drugs and other substances, while actively hunting or transporting firearms on RSA.
 - 12. Driving vehicles into food plots.
 - 13. Blocking roads, gates, or firebreaks.
- h. Scouting is permitted during daylight hours only after processing through EMD and CLEO to obtain permission to scout. Details of the scout will be given. Use or possession of weapons, calls, or decoys are prohibited when scouting. There will be no scouting once archery deer season begins.

7. WEAPONS AND AMMUNITION

- a. See Appendix B for authorized weapons in hunting areas.
- b. The only straight-wall cartridge rifles allowed are as follows:

- 1. .357 magnum
- 2. .44 magnum
- 3. .45 Long Colt
- 4. .444 Marlin
- 5. 45-70 Govt.
- 6. 350 Legend
- 7. 450 Bushmaster
- 8. Shotguns for Deer: 20-10 gauge (Slug only. No Buckshot permitted.)
- 9. Shotguns for Turkey: .410 (Tungsten loads only) thru 10 gauge
- 10. Muzzleloaders (.40-.54)
- 11. Shotguns for small/other game (.410-10 gauge)
- 12. Archery equipment may be used for hunting. Pellet rifles may be used for small game only (.17 .22).
- c. Hunters must use weapons, ammunition, and archery equipment that complies with Federal, State, and Local Law which also corresponds to the animal species they are hunting. Buckshot, no larger than 00 buck, is authorized for use on coyotes from 10 May to 30 September. Use of pellet rifles, no larger than .22 caliber, is limited to squirrel hunters and trappers. Firearms shall not be loaded with more than 5 rounds in the weapon while hunting deer and three rounds for waterfowl. Possession or use of shotgun/rifle combination firearms are prohibited. Use or possession of suppressors or silencers are not authorized for hunting on the installation. AR platform and handgun use is not authorized.
- d. Weapons must be registered with the DES, Law Enforcement Division, where a weapons permit will be generated. Archery equipment is exempt from this requirement. Weapons permits may remain valid for 5 years from 1 September of the year issued, provided the permit holder does not intend to add new or additional weapons to the permit.
- e. Hunters will observe a 300-foot minimum distance from buildings, structures and boundaries. Hunters will not fire from or across any road.
 - f. Approved weapons for hunting will be transported and stored unloaded, separate

from the ammunition, and secured in personally owned vehicles. Hunters are only authorized to transport weapons on RSA for the purpose of hunting if they are scheduled in the I-Sportsman system to participate in hunting activities that day. Firearms must be secured in a locked case or equipped with a trigger/gun lock IAW USAG RSA 190-4.

8. TURKEY HUNTING

- a. Season: Spring season only during Alabama State Law dates.
- b. Bag limit: One per day. Limits established annually by Wildlife Biologist.
- c. Turkey hunters are required to wear a cap/hat or vest of hunter orange while walking to/from set-up sites. Once stopped and set up, the orange cap may be removed.
- d. Legal weapons, ammunition, prohibited methods, and devices must comply with State law and paragraph 3, section D (para 3 (d)).
 - e. Turkey hunting hours start 30 minutes before sunrise and end at 1600 hours.
 - f. Turkey hunting is prohibited on any portion of WNWR.

9. DEER HUNTING

- a. Season: Per Alabama State Law.
- b. Bag Limit: Limits and buck restrictions are set annually by the Wildlife Biologist in conjunction with applicable Alabama State Law.
- c. Safety Garments: Per Alabama State Law and this policy; hunters additionally will maintain hunter blaze orange hat or vest during gun deer season while in the tree stand.
- d. Prohibited Methods and Devices: Deer decoys, game cameras, and salt licks (including Trophy Rock) are prohibited to use or possess on RSA. Other prohibitions are per Alabama State Law. Weapons must comply with, para 3 (d) of the Alabama State Law.
 - e. Hunting hours begin 30 minutes before sunrise and end 30 minutes after sunset.
- f. RSA residents may dispose of non-edible animal parts in authorized wooded areas at least 1,000 feet from any road or building. Those not living on-post must dispose of remains off-post. This does not prevent hunters from field-dressing animals while still in their assigned hunting area if desired.

g. Legal weapons, ammunition, prohibited methods, and devices are per Alabama State Law, and under para 3 (d).

10. OTHER GAME SPECIES

- a. Beaver, Groundhog, Coyote, Feral Hog, Feral Cat and Skunk: Per Alabama State Law, using weapons and ammunition authorized for use under para 3 (d).
- b. Raccoon and Opossum: Per Alabama State Law using weapons and ammunition authorized for use per para 3 (d). Non-toxic shot required on WNWR.
- c. Mourning Dove, Squirrel, and Rabbit: Per Alabama State Law; however, weapons and ammunition used must be authorized for use in accordance with para 3 (d).
- d. Waterfowl may be hunted only by active duty and retired service members and their authorized quests.

11. DOGS

- a. Dogs may be used to hunt the above-listed Other Game Species. Hunters must have owner contact information on the collar of each dog used. If a dog cannot be retrieved at the end of the day's hunt, the dog's owner must contact RSA police before leaving the post at 256-876-2222 or Dispatch at 256-544-4356, report that the dog is not retrieved, and give officials contact information. When notified by a RSA official that their dog has been located, the owner must respond promptly to retrieve the dog. Failure to follow this procedure may result in a suspension, citation, or inability to use dogs in the future. Only four dogs per group may be loose to hunt at a time.
- b. Dog Training must be approved by the Natural Resources Wildlife Biologist. No training will occur during turkey season, or during May and June. Alabama State Law applies in addition to the previously mentioned requirements.

12. FISHING

- a. Fishing is authorized in designated areas, locations which are posted at Building 5138. Bradford Sinks and Igloo Pond availability is posted on the weekly range report. When Bradford Sinks is open, anglers must sign up before going to fish. Creel/size limits, equipment, and methods are per Alabama State Law. Boats are limited to electric motors or manual propulsion on RSA. A state fishing license is required for those 16-64 years of age.
 - b. Rock Pond and Large Rock Quarry are closed to fishing.
- c. Magnet fishing is prohibited. Magnet fishing is the practice of using a strong magnet(s) attached to a rope or line to search for or retrieve metal objects, usually in

water. This activity is dangerous due to the possibility of disrupting Unexploded Ordnance (UXO)/chemical containers. Magnet fishing is not considered fishing as contemplated by this policy, as there is no reasonable expectation or attempt to catch an actual fish. Persons found in possession of magnets attached to ropes/lines on RSA will be suspended from access for 3 years (See Appendix A).

13. TRAPPING

- a. Trapping is permitted only in designated areas, locations of which are posted on I-Sportsman at the Natural Resources Annex, Building 5138. Persons wanting to trap will submit a written request to the Natural Resources Wildlife Biologist. If approved, trappers will provide a map showing trap locations and notify EMD/NR when traps are removed.
- b. Trappers will provide the Wildlife Biologist a weekly report listing all animals trapped that week. Traps will be checked daily and marked with owner information.
- c. Alabama State Law applies in addition to the above-listed requirements. Trapping is prohibited on WNWR.

14. BICYCLES AND E-BIKES

- a. Hunters may use bicycles including pedal-assist electric (E-assist) bicycles to access hunting areas. Bicycles must have markings or placards which identify the owner's full name and contact information.
 - b. Throttle automatic and/or self-propelled vehicles are not authorized.
- c. Bicycles and E-assist bikes are authorized for use only on roads and improved trails, paved or unpaved to access hunting areas. Bicycles are not authorized for offroad or unimproved areas (forest, pasture, etc.).
- d. Animals and equipment including guns may not be carried on the person while riding a bicycle.
- e. Animals and equipment including guns may be transported in an original equipment trailer, not modified from the manufacturer and rated for a carrying payload capacity of 400 lbs. or greater.
 - f. Bicycles must be removed from hunting areas at the end of the hunt.
- g. Users must adhere with RSA Policy 190-5, Bicycle Traffic Safety, while operating bicycles anywhere on RSA.

15. SAFETY

- a. EMD staff, Conservation Officers, or Police Officers may refuse or revoke permission to Hunt, Fish, or Trap, for anyone suspected of using, possessing, or being under the influence of any substance that compromises safety.
- b. Boats launched from or on RSA will conform to all applicable federal and state requirements. Hunters using boats to access a hunting area must launch from RSA, place a dash placard in the vehicle at the launch site, and must also leave the same information clearly visible on the boat. An approved personal floating device is required while boating.
- c. No person will attempt to touch or move any item of equipment not belonging to them. Those encountering suspected UXO or any suspicious item (i.e. cameras/tree stands), will not touch the item(s). Personnel will mark the location and notify authorities. Note: Installation biologists and conservation law enforcement utilize game cameras for mission-related work.
- d. Hunters using tree stands must use a safety belt/harness that can support the hunter's weight and shall be always attached to the hunter tree, when the hunter is not on the ground. Hunter is required to always maintain a hunter blaze orange vest or hat during gun deer season while in his/her tree stand.
- e. No hunter shall drive, drill, screw, or otherwise insert any metal object into a tree or hunt from a tree which has been prepared in such a way.
- f. Anyone involved in or having knowledge of an unsafe shooting incident will report the incident to the RSA Police and EMD immediately.

16. VIOLATIONS AND PENALTIES

- a. Those having knowledge of in-progress wildlife violations, or violations less than 90 days old, will immediately report such violations to Conservation Officers or RSA police. Failure to report may result in a suspension of privileges per the discretion of the Deputy GC.
- b. RSA law enforcement officers are authorized to issue citations for violations of State of Alabama laws. These violations will be adjudicated by the State of Alabama.
- c. RSA Law enforcement officers are authorized to issue citations for violations of this Policy. These violations are specific to hunting on RSA and are listed in the Appendix A. The penalties for violation of this policy, are suspension or revocation of access privileges to recreational Hunting, Fishing, and Trapping on RSA. Violations will be logged in the I-Sportsman permit system. Permits will not be issued within the suspension/revocation period.
- d. Individuals for whom revocation of these privileges is proposed will be notified by letter from the DES Law Enforcement Division. Suspensions of 60 days or less

cannot be appealed. Individuals wishing to appeal suspension or revocation of privileges of 90 days or greater must do so in writing within 10 days to the DES, Deputy Chief of Police. Requests for appeal must contain reasons and/or mitigating factors pertaining to the violation.

- e. Appealed suspension notifications (90 days or greater) will be reviewed by the RSAHRB. See Appendix B for the Memorandum for Record authorizing the RSAHRB. The RSAHRB will convene within 45 days of receipt of appeal request and conduct a vote to uphold or modify the suspension. The Deputy GC shall act as the final decision authority for appealed suspension.
- f. If a violation results in a criminal act, the violator will be immediately suspended from hunting/fishing activities. Criminal violations will be enforced by the RSA Police Department.
 - g. All administrative sanctions will run concurrently.
- h. Sponsors are responsible for the conduct and safety of their guests and family members. Penalties assessed for violations committed by guests and family members will also be assessed against the sponsor.
- i. Any Hunting, Fishing, or Trapping violation/penalty not specifically listed in Appendix C will be determined by the Deputy to the GC under the consultation of the legal representative.
- j. Criminal or Administrative acts that are not under the authority of the State of Alabama or RSA Policy will be forwarded to the appropriate legal or administrative authority.

APPENDIX A Violations and Penalties

All violations are subject to local, State and Federal Law. Citation/violations of State laws, which typically carry monetary fines shall be adjudicated by the State authority. The following table presents violations specific to a military installation and not covered under state law. These penalties are established by this policy and will be enforced with access privileges administered by the EMD/Natural Resources I-Sportsman fee permitting process. Multiple instances of minor violations may also result in a permanent revocation of access. Appeals may be submitted within 10 days to the RSA Deputy Chief of Police.

- 1. Purpose. The purpose of the RSAHRB is to review appeals to violations of the Redstone Arsenal Game and Fish Policy, determine if the violator is subject to administrative action, and if appropriate, administer administrative action for said violations.
- 2. Reference. Redstone Arsenal Policy 200-3, Redstone Arsenal Hunting, Fishing and Trapping Policy.
- 3. Mission. The mission of the RSAHRB is to enforce the Garrison Commander's policy regarding Hunting and Fishing on Redstone Arsenal. The board is tasked with conducting a fair and impartial review of the totality of the circumstances regarding the violation and developing an informed decision on whether the violation should have administrative action taken against them in accordance with Appendix A, RSA Policy 200-3.
- 4. Execution.
 - a. Voting Members of the Board:
 - (1) Deputy Chief of Police (Board Lead)
 - (2) Supervisory Police Detective
 - (3) RSA Directorate of Plans, Training, Mobilization and Security Representative
 - (4) RSA Garrison Safety Officer

- c. The Board Lead will provide the panel with a written summary of the incident that includes:
 - (1) Violator Information
 - (2) Type of Violation
 - (3) Administrative Penalty(s), IAW RSA-P 200-3
 - (4) Previous Violation Information
 - (5) Summary of Incident
- d. The board will meet on the last Thursday of each month (Sep-Feb). Unless there are no appeals to be considered. Suspensions issued to violators within 3 days of a scheduled board will not be reviewed until the following month.
- e. Voting Board members will review the provided information to develop a consensus regarding what action to take and provide that consensus to the Board Lead. In the event a consensus cannot be achieved, the Board Lead will make the final vote on a determining action.
- f. Non-Voting members should be present to provide legal and environmental impact of actions under review and provide subject matter expertise to assist in developing the outcome of each review.
- g. In determining an administrative action, there must be at a minimum (4) four board members to develop the consensus and/or quorum.
- h. If a legal or SJA representative is not in attendance they will be provided a record of the minutes of the board and administrative penalty recommendations for review prior to notifications being made to the violator.
- 5. Initial Appeals. Person(s) wanting to file an appeal for an administrative action must fill the appeal within (10) ten days of their notice of violation. Appeals will be in writing and provided either via email or postal service to the following:

6. Notification. Once a determination is made, a formal letter will be prepared by the Board, and the violator will be notified via registered mail of the RSAHRB decision.



8. Appeal Notification. Upon receipt of an appeal request the Deputy Garrison Commander will review all RSAHRB documents concerning the decision, and any evidence and request for consideration provided by the violator, prior to make a final decision based on any findings. The respondent will be notified in writing of the Decision of Appeal within 14 days of its receipt.
